## NOTE.

On account of the passing of a large number of enactments during recent years it has become increasingly difficult, in the absence of an up-to-date index, to know the exact position of law as it stands at present. During the last six years alone (1114 to 1119), more than one hundred and sixty enactments were passed. They comprise *main* Acts (which may be either *consolidating* Acts like the Criminal Procedure Code, the Companies Act, etc., or *new* Acts like the Merchandise Marks Act, the Trade Marks Act, etc.) as well as *amending* Acts. The latter class consists of two categories, *i. e.*, amending Acts which *directly* amend the main Acts (e. g. the Civil Procedure Code Amendment Act amending the Civil Procedure Code, the Insurance Amendment Act amending the Insurance Act, etc.) and Acts which *inter alia* introduce amendments in *other* Acts (e. g. the Debt Relief Act amending the Civil Procedure Code, the Merchandise Marks Act amending the Penal Code, the Probate and Administration Act amending the Court Fees Act, the Edavagai Act amending the Estates Rent Recovery Act, etc). The only way to avoid pitfalls under such a complicated system of legislative drafting is to keep a complete and up-to-date index.

2. The index now prepared has been brought up to the 31st May 1945. In the case of the Acts and Proclamations till the end of the year 1118, references are given to the volumes, and in the case of those for 1119 and 1120 (till 18-10-1120), to the Gazettes in which they are published. A chronological list of enactments passed in 1119 and 1120 (till 18-10-1120) is added as an appendix.

3. The index would also facilitate the work of a republication of the whole series of Acts and Proclamations, (which work should necessarily be preceded by the passing of a general Repealing and Amending Act) and would, at the same time, serve as an easy reference guide till such work is undertaken.
