SUB:-Stocking of paddy by land holders.

REF: -Your letter R. O. C. No. 72/44 dated 18-10-1944.

In the circumstances stated in your letter cited above. Government sanction the period for which land-holders may be allowed to transport or stock paddy or rice for domestic consumption being revised and fixed as six months, except in the case of persons who own or cultivate single crop lands exclusively, in which case the existing period of 12 months will be allowed.

Several applications have been received from political pensioners whose pension is payable partly in paddy and partly in cash or wholly in cash only, either for conversion of the money into paddy or for permission to purchase paddy with such amount. Some political pensioners and Thampurans have asked for the continuance of the supply of rice or paddy sanctioned in their favour before the Rationing Act was passed.

Government consider that a uniform rule should be laid down in the matter and accordingly they order as follows:-

(i) Political pensioners whose pension allotment is in paddy

will be paid entirely in paddy.

(ii) Wherever pension is payable partly in paddy and partly

in cash, paddy portion will be given in paddy.

(iii) Apart from the allotment of pensions either in paddy or money every one of them will be entitled to the ordinary rations in common with others subject to such reduction as will necessarily be made to the extent the pension is paid in paddy. They cannot claim any quantity in excess of the ordinary scale of rations by virtue of their being political pensioners.

(iv) If, however, the quantity of paddy paid as pension is in excess of the rations ordinarily allowed under the rationing rules. they will be permitted to retain the whole quantity of paddy paid as pension. If the paddy given as pension falls short of the quantity which otherwise they would be entitled to under the rationing

rules, they will get rations to the extent of the deficit.

(v) The rate of consumption, for purposes of calculation will be on the same basis as in the case of land holders.

(vi) The pensioners whose pension is totally inadequate for their ordinary needs and other Thampurans who may have no such pension, will be entitled to the ordinary scale of rations. In other words the ordinary rules will apply in their case both in regard to rationing as well as the purchase of paddy.

Rationing Officers accordingly.

(12) PRESS NOTE.

Under the existing scale of rations a unit consists of 3 1/2 nazhies of rice, 2 nazhies of wheat and 1/2 nazhi of pulses or gram, An adult, being allowed 2 units of ration per week, gets 7 nazhies of rice, 4 nazhies of wheat and 1 nazhi of gram or pulses. Converted into weight the daily ration of an adult works to 1 lb. of foodgrains consisting of about 10 ozs. of rice, 5 ozs. of wheat and 1 oz. of gram or pulses.

Government have now decided to raise the rice portion of the ration to 4 1/2 nazhies per unit with effect from 28th January 1945/15th Makaram 1120. The wheat portion will be 1 1/2 nazhies. No change is proposed to be effected with regard to pulses or gram. The present revision will thus provide a weekly ration of 9 nazhies of rice, 3 nazhies of wheat and 1 nazhi of gram or pulses to an adult. Calculated in weight an adult will get over 12 ounces of rice, about 4 ounces of wheat and 1 oz. of pulses or gram, making up a total of over 17 ounces of food grains per day.

In view of the general increase in the size of ration, the supplementary ration of 50 per cent of the basic ration allowed to heavy manual labourers will be reduced to 25 percent of the basic ration. A heavy manual labourer will thus get a daily ration of over 21 ounces of food grains under the present revision as against 19 1/2 ounces originally allowed inclusive of the 50 per cent supplementary ration.

Government have also decided to issue 50 per cent of the wheat portion of the ration as wheat products to house holders getting a monthly income of not less than Rs. 50.

Representations have been made to Government by private individuals including members of the Legislature that notwithstanding the rules of the subject, the local Purchase Officers insist on the sale of the minimum quota of paddy on the basis of the settlement Pattom in cases where the crop has failed or the yield is poor. The attention of the Purchase Officers is drawn to the Press Note dated 1-9-1943 authorising them to allow concessions or grant total exemption from the sale of quota in cases in which there is poor yield or there is failure of crop. It has also to be clearly borne in mind that the members of local non-official committees should be freely consulted in ascertaining the gross yield if there is doubt or dispute as regards the total yield obtained from any holding so as to avoid hardship to parties. The purchase officers are therefore requested to see that in accordance with the spirit of the rules and instructions issued by Government in the matter procurement scheme should be worked out so that no undue hardship is caused to parties.

PRESS NOTE.

Under the existing scale of rations a unit consists of 4 1/2 Nazhies of rice, 11 Nazhies of wheat and 1 Nazhi of gram or pulses. Government have now decided to raise the rice portion of the ration to 5] Nazhies and to reduce the wheat portion to 3 Nazhi per unit with effect from Sunday the 20th May 1945/7th Edavom 1120. An adult being allowed two units, the present revision will provide to an adult a weekly ration of 10 1/2 Nazhies of rice and 1 1/2 nazhies of wheat. Calculated in weight the daily ration to an adult comes to about 14 ozs., of rice and 2 ozs., of wheat making up a total of 1 lb., of foodgrains.

Along with the above rations gram or pulses also will be issued at the rate of 1/2 Nazhi per unit for some time.

PRESS NOTE DATED 23RD JUNE 1945.

In order to afford further relief to the people of the State under the ration scheme, the Government of Travancore have been pleased to reduce the selling price of rice from Rs. 27-8-0 per bag of two maunds to Rs 26-8-0 per bag. Although the cost price of rice (which includes cost of transport, godown charges and other overhead charges) is higher than the reduced selling price, Government have decided to waive the loss and give substantial relief to those who depend on rationed rice.

With a view to give special facilities for the labour employed by the P. W. D., Forest and other Government Departments to procure rice, it has been decided that the wages of these employees should be paid half in kind (rice or paddy) and half in money.

Similar facilities will be given, if applied for, to factories and other private organizations.

The authorities in charge of educational institutions including Managements of Grant-in-aid schools will also be given facilities for procuring such quantities of rice as may be required for provision of noon-day meals for school children at concessional rate of Rs. 25 per bag. All bonafide applications made by the Educational authorities will be promptly dealt with by the Director of Food Supplies. This concession will be given for the next three months.

PROCEEDINGS OF THE GOVERNMENT OF HIS HIGHNESS THE MAHARAJA OF TRAVANCORE.

A Conference of the Financial Secretary to Government, Accountant General, Director of Food Supplies, Additional Secretary to Government and the Registrar, Huzur Secretariat, was held at 6 P. M., on the 16th June 1945 to consider the reorganisation of the Food Department and to make recommendations to Government These recommendations are now before Government.

Order thereon R. O. C. No. 5282/45/C. F. S., dated 9th,/10th July 1945.

- 1. Government having considered the recommendations of the Conference sanction the following arrangements:—
- 1. The Director of Food Supplies will be the head of the Food Department and he will exercise for the present, all such administrative and disciplinary powers as are vested in the Director of Agriculture. All the prescribed statements and returns (including the weekly statements) will be submitted to Government by him.

2. PROCUREMENT.

- (a) Outside the State. The Director of Food Supplies will attend to all items of work connected with procurement, movement of quota, transport etc., from British India and States other than Cochin and Travancore. All the officers working in British India will be under his control.
- (b) Within the State. The Food Grains Purchase and State Food Rationing Officer will hereafter be under the administrative control of the Director of Food Supplies, who will be in charge of the local purchase of paddy also.
- 3. Release of foodgrains will be sanctioned by Government ordinarily on the recommendation of the Director of Food Supplies. Government will communicate such sanctions to the District Magistrate on special duty in the case of stock held by him.

District Magistrate on Special duty. In addition to his present item of work and powers of control, the District Magistrate on special duty will be in charge of the whole stock of imported food grains as disclosed by the verification thereof with which work he is now entrusted and exercise administrative control over the Depot staff and the Stores Officers within the State. In all respects he will work directly under Government. The District Magistrate on special duty will submit to Government all the prescribed returns. In cases where any such returns are urgently required by the Director of Food Supplies, copies of the same would be sent to him by the District Magistrate direct.

Assistant Director of Food Supplies. The Assistant Director of Food Supplies who is now functioning also as an Assistant Secretary to Government will hereafter cease to function as Assistant Secretary to Government and will be the Assistant Director of Food Supplies.

Accounts. (1) The entire audit staff in the Office of the Director of Food Supplies will be transferred to the control of the Accountant General.

- (2) All foreign accounts will be maintained by the Director of Food Supplies and accounts and returns relating to the same will be sent by him to the Accountant General.
- (3) Depot accounts will be obtained by the District Magistrate on special duty and forwarded to the Accountant General.
- (4) Paidy accounts will be obtained by the Director of Food Supplies and forwarded to the Accountant General.
- (5) The special audit staff at Ernakulam will be under the control of the Accountant General.
- (6) The Assistant Director of Food Accounts, who is in charge of all Food Accounts will hereafter be designated as Assistant Accountant General and will be under the control of the Accountant General.

Sub:-Purchase, storage and distribution of local paddy.

In accordance with the announcement made by Government in their Press Communique dated 3-1-1946, Government sanction the continuance of the purchase of local paddy, subject to the following modifications:—

- 1. The purchase of paddy will be on settlement Pattom and excess basis, but in the matter of purchase under settlement Pattom, paddy will be purchased only from holdings of one acre and above.
- 2. Instead of the stock being purchased direct by Government as was done hitherto, authorised merchants will be required to purchase paddy from specified areas. The merchants so authorised should work under the control of the Tahsildar of the Taluk, who will specify to them the parties from whom stocks should be purchased and the quantity to be purchased from each of them.
- 3. The Division Peishkars will be the supervising and final authority in respect of the purchase work in their respective Divisions.
- 4. The Schedule of prices for sale of paddy to the consumers for each area will be fixed by the respective Division Peishkars with the previous approval of Government.
- 5. The Tahsildars of all the Taluks except Devicolam and Peermade, will be given an Executive Assistant each, on a pay of Rs. 70 in the scale of Rs. 45.6-75 with a P. T. A. of Rs. 25 per mensem for helping the Tahsildar in connection with this work.
- 6. An Accountant on Rs. 18 per mensem will be given to each Tahsildar to help the Executive Assistant in his clerical work.

The selection of the Executive Assistants and Accountants will be made by the respective Division Peishkars in consultation with the Tahsildars concerned.

The expenditure on account of the staff will be met from the provision under "44A—Food and other Control Measures—4 Paddy Purchase and State Rationing Scheme" in the budget for the current year.

The stock of paddy purchased will be distributed under rationing, as at present, on the recommendation of the Director of Food Supplies.

I request that you will be so good as to take necessary steps immediately to give effect to the revised arrangements and forward a detailed report to Government of the action taken in the matter together with the schedule of prices for approval.

G. O. R. O. C. No. 848/46/Con., dated the 17th January 1946 to the Director of Food Supplies.

Sub:-Storage and distribution of imported foodgrains.

Since arrangements have been made to move the quotas of foodgrains alloted under the Kharif Plan 1945/46 direct to the State-Government have decided to introduce the following measures with regard to their storage and distribution:—

- (1) The stocks so imported will be stored at the depots at Trivandrum, Quilon, and Alleppey alone, closing down the depot at Haripad, Shertallai, Changanacherry, Kottayam, Vaikom, Alwaye and Parur, as soon as the present stocks in them are depleted.
- (2) The wholesale merchants in the State will be permitted to procure the quantity of imported foodstuffs allotted to them for a period of a month or two weeks at a time, direct from the nearest depot. They should make their own arrangements in respect of transport and storage.
- (3) When the wholesale merchants procure their allotments direct from the depots, there will be no necessity to commandeer vallous for transport of foodgrains and hence the commandeering of valloms by Government will be stopped.
- (4) The class of merchants called "stockists" will be discontinued, but the wholesale merchants will be allowed a reasonable margin of profit to cover the transport and storage of foodgrains and other incidental expenses.
- (5) All the depot will be under the immediate supervision of the State Food Rationing Officer, subject to the administrative control of the Director of Food Supplies, with effect from 1-7-1121 when the post of the District Magistrate on Special Duty will be abolished.
- (6) The depots at Trivandrum, Quilon and Alleppey will each be in charge of an officer of sufficiently high status. He will be assisted by an adequate staff to cope with the increased work.
- (7) Each Depot Officer will be given an adequate permanent advance for meeting the incidental expenditure of the depot, which will be recouped on bills preaudited.
- (8) There will be concurrent audit of the accounts of the depots for which a separate audit staff will be detailed in each depot.

In exercise of the powers conferred by sub-rule (2) of Rule 81 of of the Defence of Travancore Rules, the Government of His Highness the Maharaja are pleased to make the following order and to direct with reference to sub-rule (1) of Rule 119 of the said Rules that notice of the Order shall be given by the publication of the same in the Government Gazette and by the issue of a Press Note indicating the nature of the provisions.

- 1. (i) This Order may be called the Paddy (Acquisition, Distribution and Movement) Control Order, 1121.
 - (ii) It extends to the whole of Travancore.

(iii) It shall come into force at once.

- 2. In this Order, unless there is anything repugnant in the subject or context:
- (a) "Licensed Dealer" means a dealer licensed to purchase, stock and sell paddy under this Order.
- (b) "Stock holder" means a person who on his own account or on account of any other person holds any stock of paddy.
- (c) "Paddy" includes rice, whether raw or boiled, and also sheaves;

(d) "Form" means a form appended to this Order;

- (e) "Executive Assistant" means the Officer appointed by the Government to assist the Tahsildar in the supervision over the acquisition and distribution of paddy, under this Order.
- 3. No person who owns or is in possession of any land from which he receives paddy by his own cultivation or otherwise and no stock holder shall sell or otherwise dispose of any paddy except to a licensed dealer and in accordance with the directions issued in that behalf by the Tahsildar.
- 4. A licensed dealer shall be competent to purchase paddy from such stock holders in such area and in such quantities as the Tahsildar may from time to time by written order direct.
- 5. (1) Every person who owns or is in possession of any land having an extent of one acre or more from which he receives paddy by his own cultivation or otherwise shall be liable to sell to a licensed dealer paddy in quantities equal to the settlement pattom due on each such land:

Provided that it shall be open to the Tahsildar to reduce the quantity to be purchased from any person in cases in which the entire quantity could not be purchased on account of failure of crops drought flood or damage by insects and also to order that the quantity due to be sold by any person may be purchased in instalments:

Provided further that the Tahsildar shall purchase a reasonable proportion of the yield from any land on which paddy is cultivated and the settlement pattom of which is fixed in cash.

,

- (2) Notwithstanding anything contained in sub-clause (1) every stock holder shall also be liable to sell to a licensed dealer such quantity of paddy which is in excess of the quantity reasonably required by him for stocking of seed cultivation expenses and for bonafide domestic consumption, as the Tahsildar may by written order specify in each case.
- 4. A licensed dealer purchasing any stock of paddy under clause shall pay to the stock holder the price there of at such rate as the Government may fix from time to time.
- 7. (1) Any person wishing to become a licensed dealer shall apply to the Tahsildar in Form A.

(2) The Tahsildar may, if he is satisfied that the applicant is a fit person to be a licensed dealer, issue to him a license in Form B

- (3) The applicant to whom a license is granted under subclause (2) shall execute a bond in such form and for such amount as the Tahsildar may require binding himself to carry out the purchase, stocking and distribution of paddy in accordance with the terms and conditions of the license and such directions as may be issued by the Tahsildar.
- (4) The license in Form B shall specify the area within which the licensee shall purchase paddy.
- 8. A licensed dealer shall purchase all stocks of paddy which he is authorised to purchase on payment of the price thereof at such rate as may be fixed under clause 6.
- 9. No licensed dealer shall sell any portion of the paddy purchased by him except in accordance with such directions as may be issued by the Tahsildar.
- 10. Every licensed dealer shall keep such books and accounts and furnish such returns in such form and at such times as he may be required to keep or furnish under the terms of his license.
- 11. The Tahsildar shall have power to delegate to his Executive Assistants all or any of his powers and functions under this Order with the permission of the Division Peishkar.
- 12. Where the Tahsildar is satisfied that any party has refused to sell to the licensed dealer the quantity of paddy fixed by him, the Tahsildar or the Executive Assistant shall acquire the quantity so fixed from the stock held by the defaulter or his agent and for the purpose of acquisition the said officer shall have power to enter upon any premises wherein such stock is believed to be kept and inspect such premises and any property or thing thereon and take such other steps including the sealing of barns or other receptacles wherein paddy is stored as may be deemed necessary for the acquisition and custody of any stock of paddy found thereon.
- 13 Every Division Peishkar shall also be competent to acquire paddy in all cases of emergency.
- 14. With a view to securing compliance with the provisions of this Order the Tahsildar, his Executive Assistant or a Police officer duly authorised by the Tahsildar shall have power—

- (a) to require any person to give such information in his possession with respect to any business carried on by that or any other person as he may demand.
- (b to inspect or cause to be inspected any books or documents belonging to or under the control of any person.
- 15. No person shall transport any stock of paddy in any form from any one place in a Taluq to any other place outside such Taluq except under and in accordance with the terms and conditions of a permit issued in that behalf by the Tahsildar.
- 16. (1) Any person aggrieved by an order of the Tahsildar or of his Executive Assistant may within 14 days of the date of the order appeal to the Division Peishkar who may pass such orders thereon as he may deem fit, and a revision shall lie to the Government from the orders of the Division Peishkar.
- (2) Any person aggrieved by an order of the Division Peishkar under clause 1 may within one month of the date of the order appeal to the Government and the decision of the Government on such appeal shall be final.
- (3) In computing the period of limitation under sub-clauses (1) and (2), the time taken for obtaining a copy of the order appealed against shall be excluded.
- 17. (1) Infringement of any of the provisions of this order shall be punishable under Rule 81 of the Defence of Travancore Rules.

Without prejudice to any action that may be taken against him under sub clause (1) of this clause, any holder of a license issued under this Order who contravenes any of the conditions of his license shall be liable to have his license cancelled, the whole or any portion of the security offered by him to be forfeited and the stock of paddy and the records relating to the purchase, stocking and sale of paddy under this Order to be taken into the custody of the Tahsildar in pursuance to an order passed by the Tahsildar in that behalf.

- 18. The Executive Assistant shall be under the control of the Tahsildar. The Tahsildar shall act under the directions of the Division Peishkar and he shall keep such registers and furnish such returns as may be required by the Division Peishkar.

It need hardly be stated that all personal and private interests must be subordinated to the needs of a situation like the present. The public are informed that under no circumstances will permits be issued for the export of either raw tapioca or dried chips from the State. As there is an imperative necessity to conserve and make available as much food stuff as possible for the consumption of the people, Government are issuing a notification prohibiting the conversion of tapioca into flour. This notification will not however apply to the preparation or possession of tapioca flour not exceeding ten pounds for purpose of local consumption.

PRESS NOTE.

In view of the need for improving the food situation in the State, necessary measures are being taken to speed up purchase of local paddy as announced at the Press Conference held on the 20th March 1946. Representations have been duly made to the Government of India to make further allotments needed.

It is also very essential that steps should be taken immediately to conserve here as much of food grains as possible. for the creation of reserve stocks to meet any emergency that might arise during the lean months of the year. When the available stock of food grains in the country is hardly sufficient to meet bonafide demands of the consumers the ration scheme has to be continued to be strictly enforced.

It is hoped that the public would realise the importance of the question and lighten the work of the concerned officers of Government. Having this in view, Government find that it is necessary to restrict the number of persons that may be fed at social and religious parties and functions. This number could not be permitted to exceed 30 persons. Instructions have been issued to the Rationing Authorities not to issue special ration ordinarily and not more than quarter of a bag of rice as special ration for any bonafide applicants for the above functions. Government in this connection would appeal to the public to give their unstinted cooperation and to fall in line with the above decision of Government.

In the circumstances stated. Government sanction the rate of paddy now allowed to the cultivators for their bonafide domestic consumption being revised and fixed as 3 Nazhies...(three) per adult per day. Necessary instructions may be issued to the Area Rationing Officers in the matter.

Press Note dated 5th April 1946.

It has been brought to the notice of Government that certain persons or organisations on the plea of assisting Government in stamping out black market in foodgrains, etc. are unlawfully detaining persons and food grains under transport and are interfering in an unauthorised manner the distribution etc.

Government welcome co-operation of all classes of people in putting down black-market, but it must be clear that none should infringe the law. Government have already appointed a large staff and invested them with necessary powers. It is only essential and desirable that such public-spirited men should work through these authorities. Any attempt to take the law into their own hands and

take direct action will make such persons liable to action under the law and defeat the purposes held in view by them and the Government. The authorities will be bound to take action on complaints of such misguided activity quite apart from motives which occasioned such activity.

Government also wish to make it plain that it is the duty of Government servants including quasi-Government servants to see that every complaint brought to their notice as properly dealt with and taken to the appropriate authority promptly. The failure on the part of any official to deal with such complaints should be reported to the Head of his department, who will deal with each case in a deterrent manner and keep the Government informed.

PRESS NOTE.

With a view to intensifying the cultivation of tapioca, Government have already instituted a bonus scheme. The Division Peishkars are arranging with dealers for adequate stocks of tapioca being kept in sale depots situated as far as possible, near ration shops and markets. These stocks would be sold to the general public at controlled rates under the direction of the local Tahsildars. After taking into consideration all aspects of the question regarding the present high labour charges cost of manure etc., Government have come to the conclusion that the price of raw tapioca should be enhanced to 1 1/2 chs. per pound and that of dry chips to 4 chs. per pound. The necessary notification is being issued. It is hoped that the enhancement of price as well as the distribution of bonus would enable the cultivators to increase the production of tapioca in the State.

Government consider that the provisions of the Rationing Order are not being rigidly followed in all cases and that with a view to conserve as much of food grains as possible and to avoid all waste, it is necessary to work out the Rationing Scheme strictly. The following instructions are issued for the guidance of the Rationing Officers.

- 1. The City Rationing Officer and the Municipal and Taluk
 Rationing Officers should see that the ration for a fortnight is
 limited to the off-take of the preceding fortnight as far as possible
 the increase, if any, being clearly explained.
 - 2. The registers, day books and accounts that are being maintained both by the authorised wholesale distributors and the retail distributors, should be periodically checked by the Officers authorised to do so. Register No. 4 should be checked along with the connected register in the office of the Area Rationing Officers, by the Deputy Tahsildars in the case of the Taluk Rationing Areas and by the Head clerks in the case of the City and Municipal Rationing Areas.
 - 3. Applications for the issue of new ration cards and those for raising the existing number of units should be subjected to the closest scrutiny by the Rationing Officers concerned and such applications shall be allowed only after obtaining due sanction from the Division Peishkars concerned.
 - 4. A fee of Re. 1 should be realised as payment for a lost ration card instead of the existing rate of (4) four chuckra ms.
 - 5. Surprise checking of ration cards with the quantities actually sold to the consumer should be done in order to ascertain whether the quantity actually given and that marked in the card as issued tally.
 - 6. The merchants are prohibited from retaining in their possession the ration cards of the card holders and in cases where they contravene this stipulation, action should be taken against them by cancelling their licenses. If the card holder leaves his eard with the Ration merchant then the Rationing Authorities should treat such cards as cancelled.
 - 7. The Area Rationing Officers should cancel the ration cards in the following cases:—
- i. If the card holder does not purchase ration for a period of one month without adequate reason.
- if. If he leaves the locality for a period in excess of one month without giving notice.

iii. If the card holder comes into possession of food grains and does not report the fact to the Rationing Authorities concerned.

R. O. C. No, 6837/46/Con.

It has come to the notice of Government that the number of persons who have applied for food ration cards is much larger now than during the corresponding period of last year and many instances of irregularities have been detected. Government have, therefore, decided to conduct a house-to-house checking and revalidation of the ration cards throughout the State excepting the following areas:—

- 1. The Taluks of Peermade and Devicolam.
- 2. The Municipal areas of Trivandrum, Quilon, Alleppey and Kottayam.
- 3. The estates in other taluks which get their ration through the Association of Planters of Travancore.

The checking of cards in the above-mentioned areas will be done separately later on if found necessary.

- 2. The Division Peishkars have been requested to make all necessary arrangements in their Divisions for the proper conduct of the work. The 16th and 17th May 1946 have been provisionally fixed as the dates for conducting the checking. The dates fixed will be declared as Public Holidays throughout the State to enable all Government officers to devote their sole attention to this work.
- 3. The Tahsildar will be in entire charge of the checking and revalidation work in each taluk. As the services of the official and quasi-official agencies are necessary to carry on the work satisfactorily, the Tahsildars have been asked to seek the co-operation and help of the members of the Legislature, the Chairmen of the

Municipal Councils, Municipal Councillors, Honorary Magistrates and Presidents of Village Pauchayats in their respective jurisdiction. The services of a large number of Government subordinates, including teachers in all Government institutions, will also be required. The Tahsildars have been directed to make a preliminary list of all available Government subordinates in their taluks whose services can be utilised. Heads of Departments and offices and Chairman of Municipal Councils are requested to direct their subordinates who may be selected for the work, to report themselves to the Tahsildars, take instructions from them and carry out the work satisfactorily.

- 4. The checking work will be of an honorary nature, but an allowance of Rs. 3 is provided for those who want it. The payment of the allowance will be made against receipt showing the number of check forms handed over by the checking officers to the Tahsildars.
- 5. The officers employed for revalidating the cards will be entitled to an overtime allowance for the work.
- 6. For the purpose of this work, the officers are deemed competent, without any further orders, to travel beyond their jurisdiction whenever necessary.
- 7. The Heads of Departments and offices are requested to co-operate with the officers of the Land Revenue Department and render necessary help to the checking officers, giving preference to this work over all other items of work.

Sub:—Measures to meet the present food situation in the State.

I am to inform you that Government sanction the following measures being adopted immediately to meet the present food situation in the State:—

- 1. In order to ascertain the exact demand of the consuming public, test checking of ration cards will be conducted in three localities, preferably one in each Revenue Division, on the lines of the test checking conducted in the Kadakavoor Pakuthy. Test checks will be arranged to be carried out by the Division Peishkars with the help of the existing staff and the results reported to Government.
- 2. The State Pood Rationing Officer or his Assistant will visit all Taluk Rationing Offices frequently and check the ration cards, unit registers etc., with the registers of the ration merchants and report results of such inspections to Government.
- 3. As foreign procurement is uncertain and insufficient and as the maximum quantity of paddy has to be procured locally, the old system of procurement of local paddy through Government agency will be followed. The existing system of procurement through trade agencies will be discontinued forthwith.
- anctioned to hotels and restaurants. Out of the 50 percent allowed, the entire quantity will be issued in rice in the case of hotels, but in the case of restaurants and tea shops 25 percent will be of rice and the rest in wheat, wheat products, millets or pulses. No hotel or restaurant should supply more

than three courses. The rules issued in this connection by the Government of Madras will be followed in the State also.

5. The export of fish, eggs, yams of all kinds and bananas

- and plantains from the State will be prohibited forthwith. In the case of eggs, the prohibition will be subject to the supply to the Military Depot, which will be progressively reduced in the course of a month, so that all the eggs produced in Travancore may be made available for consumption in the
- 6. The scheme or the promotion of lift irrigation in North Travancore will be taken up in Chingom 1122. Preliminary works and investigation and supply of motors etc. will be taken up
- 7. The present practice of utilising food ration cards for the purchase of textile goods will be discontinued forthwith as it creates much confusion and promotes undesirable activities. Separate ration cards for textile goods based on food ration cards will be issued by the Taluk Authorities. The Textile Commissioner will arrange accordingly.

8. In view of the reversion to the old system of procurement of local paddy through Government agency, the services of the

members of the Flying Squad will be discontinued.

I request that you will be so good as to give effect to the above measures immediately. Copies of this letter have been sent to the Chief Engineer, the Division Peishkars, the Excise Commissioner. the Textile Commissioner and the Accountant General, for necessary action.

Ref :- G. O. ROC. No. 6837/46/Con., dated 10-5-46.

Sir,

Government consider that the checking of food ration cards and their revalidation, as originally proposed, might leave outside the rationing a large number of cards and also a considerable number of house holders who may subsequently be preferring applications for ration cards. Having regard to the expenditure proposed to be incurred and the time required, Government are of the view that the better procedure would be to issue fresh application forms and fresh ration cards in the place of the existing ration cards and they order accordingly. The following procedure will be adopted for the purpose:—

Enumeration. (i) The Tahsildars shall, in the first instance, with the approval of the Division Peishkars, divide each Pakuthy into blocks based upon the census blocks and assign two enumerators for each block. Of the two enumerators one shall be a senior man.

- (ii) A register in the prescribed form (Vide copy of form enclosed) with the census numbers of the houses entered in alternate lines will be prepared in the Taluk Office and kept ready before the enumeration commences,
- (iii) The required number of enumerators will be selected by the Division Peishkars from Government servants including Primary School teachers and, if necessary, the services of suitable persons employed in private institutions, such as banks, firms etc., will also be utilised. The exact number of enumerators available will be decided on receipt of necessary information from the Inspectors of Schools concerned.
- (iv) The application form, according to the sample form enclosed, along with the register form prepared as above, will be handed over to the enumerators who must issue the application form to each household, marking therein the Pakuthy, census block and the census number of the house. Simultaneously, he will also mark in the Ration Register form kept by him, the serial number of the application form handed over to the house. If a new or unnumbered building or hut is found, the enumerator will mark it in the blankline of the register-statement in the appropriate place and issue an application form. The form will then be got filled in and signed by

the head of the family. The enumerator will conduct visual checking or physical verification of the inmates of the household mentioned in the application form. All application forms will be machine-numbered serially and will have counterfoils also containing the same serial number and also the name of the pakuthy, number of the house and the name of the house-holder.

- (v) After the form has been got filled in, the counterfoil with the entries referred to above, will be detached by the enumerator and handed over to the householder with directions to take it, on a specified date, to the Taluk Office or Pakuthy Cutcherry, as the case may be, for receiving the new ration card. The application form, duly filled up and checked, but without the counterfoil, will be taken back by the enumerator along with the register statement to the Tahsildar.
- (vi) After the application forms and the ration-register forms are received from the enumerator, the Tahsildar will arrange for ration cards and the ration register being prepared. The first four columns of the ration register having been already filled in by the enumerators, the staff engaged in the writing up of the ration cards will have to enter the remaining columns only in the register.

2. Printing of application forms and ration registers. The respective Division Peishkars will arrange for the application forms in Malayalam as well as ration register forms being got printed in private presses. The necessary paper will be made available to the Division Peishkars through the local dealers by the Paper Controller.

- 3. Printing of ration cards. The ration cards will be arranged to be got printed from the Government Press by the Director of Food Supplies. Separate ration cards will be issued for each taluk with the name of the taluk printed thereon. The Division Peishkars will furnish the Director of Food Supplies immediately with an approximate estimate of the number of ration cards required for each taluk, where enumeration is to be conducted.
- 4. The Municipal towns of Nagercoil, Trivandrum, Quilon, Alleppey and Kottayam, the taluks of Thovala, Shencottah, Peermade and Devicolam and the estate areas will be exempted from the proposed enumeration scheme for the present.
- 5. For the writing up of ration cards in each pakuthy, a special staff, preferably of Government servants, will be engaged by the Division Peishkars for a period of two weeks. This special staff will be given a remuneration at the rate of B. Rs. 1½ per day.
- 6. Each Division Peishkar will, for the time being, be given an advance of Rs. (10,000) ten thousand only, to meet the expenditure connected with the enumeration work, printing of forms etc. The amount will be drawn by them on simple receipts as and when required and will be debited to Debt Head—Foodstuff Advance. The Accountant General has been requested to place the amount at the disposal of the Division Peishkars in the respective Divisional Treasuries.

7. For the special expenses connected with this works including travelling expenses, etc., for the month of Edavam 1121, the Tahsildar of each taluk where enumeration is to be done, will be given a special allowance of Rs. 25.

8. The enumeration will be conducted on the 9th Edavam 1121/23rd May 1946 which will be declared a public holiday. If the 10th of Edavam 1121 is not already a holiday, it will also be declared a public holiday. Notifications to this effect will be issued separately.

9. Government Circular R. O. C. No. 6837/46/Con., dated 8-5-46 and Government order of even number dated 10-5-46, are modified

accordingly.

The Municipal towns of Nagercoil, Trivandrum, Quilon, Alleppey and Kottayam, the taluks of Thovala, Shencottah, Peermade and Devicolam and the estates will be exempted from the enumeration scheme for the present. The enumeration will be conducted on the 9th Edavam 1121/23rd May 1946. It is proposed to declare the 9th and 10th Edavam 1121 as public holidays. The following procedure will be adopted in the matter of issuing fresh ration cards.

Each pakuthy will be divided into blocks based on the census blocks and two enumerators will be assigned to each block. The required number of enumerators will be selected by the Division Peishkars from among the Government servants including primary school teachers. The services of employees of private institutions such as banks, firms-etc., will also be utilised. The enumerators will supply an application form to each household and get it duly filled in and signed by the head of the family. He should conduct a visual checking or physical verification of the inmates of the house-hold mentioned in the application, after which he will hand over to the house-holder the counterfoil of the form with directions to take it, on a specified date, to the Taluk Office or the Pakuthy Cutcherry, as the case may be, for receiving the new ration card.

Government trust that the public will fully co-operate with

them in making the scheme a success.

- 1. The State Food Rationing Officer to be designated Deputy Director of Food Supplies. He will also function as Assistant Secretary to Government in the Food Section. Mr. P. Balakrishna Pillai, the present State Food Rationing Officer, will be the Deputy Director of Food Supplies on his present salary including his allowances.
- 2. The present post of Assistant to the State Food Rationing Officer to be converted into Assistant to the Director of Food Supplies. This post will be in addition to the one already existing. Mr. K. Parameswaran Nair, City Rationing Officer, Trivandrum is appointed to the above post on a salary of Rs. 200 per mensem.
- 3. Mr. M. A. Bhaskara Pillai, the present Assistant to the State Food Rationing Officer, is posted as City Rationing Officer, Trivandrum, on his present pay of Rs. 195 in the scale of Rs. 175-10-225.

4. The establishment of the amalgamated office of the Director

of Food Supplies will consist of :-

i. The staff attached to the office of the Director of Food Supplies.

ii. The staff attached to the office of the State Food Rationing

iii. The residual staff of the Food Grains Purchase Officer.

iv. The residual staff of the District Magistrate on special

duty.

- v. The Secretariat staff deputed for duty in the Food section. The members of the Secretariat staff now posted for duty in the Food section will be treated as on other duty in the office of the Director of Food Supplies. They will retain their rank and lien in the Secretariat. A statement showing particulars of the personnel will be forwarded to you separately.
- 5. For all practical purposes, the office of the Director of Food Supplies will be treated as the Food Section of the Secretariat, as was done prior to the bifurcation on 1-12-1120.
- 6. The Director of Food Supplies will be ex-officio State Food Rationing Officer and will exercise the functions under the State Food Rationing Order.
- 7. The Division Peishkars will be the Chief Authorities in their respective Divisions in the matter of Food Control work, including local procurement and distribution under the Rationing

Order. The Tahsildars will, as at present, continue to be the Taluk Purchase and Rationing officers. The Division Peishkar's first and foremost duty will be to deal with Food problems. Their work will be co-ordinated by the Director of Food Supplies who will be a liaison officer as well as Secretary to Government.

- 8. The periodical allotment of stock to the different rationing areas will be made by Government only. There shall be no release of stock except under the orders of Government.
 - 9. The above arrangements will come into effect forthwith.

Government sanction the following arrangements being made for the preparation, issue and registration of fresh Ration Cards on the basis of the enumeration conducted in the State on the 13th and 14th Edavom 1121:—

I. Preparation of Ration Cards.

(A) The directions contained in the G. O. R. O. C. No. 6837/46/Con., dated 29th May 1946 (copy enclosed) for the preparation of ration cards should be followed.

(B) In regard to the issue of ration cards to households which have got their own stock of paddy either for the full season or for a part thereof, the following procedure should be adopted:—

(1) Ration cards for households having no paddy will be

issued in the first instance.

(2) In regard to the cards of persons having or expected to have paddy, the Tahsildars will verify detail before the cards are

issued and cancel the coupons for periods for which the paddy in their possession will last. This stock of paddy will also be noted on the ration cards and initialled by the Tahsildars in all cases. In deciding what such stock is the Tahsildars will, besides examining the permit or license or other records they may have in possession in respect of the parties concerned, verify the extent of the property in their possession, the quantity that may be required for seed and other purposes and the stock that may reasonably be expected to remain with them. It must be on the above basis that the requirements in the ration units should be decided and noted.

(3) All applications for ration cards from persons who own paddy lands must be initialled by the Proverthicar of the pakuthy in token of having certified that the information given is correct. For this purpose, reference should be made to other taluks and pakuthies also if necessary, to ascertain whether the party concerned possesses paddy lands in pakuthies or taluks other than the one in which he resides.

II. Registration of Ration Cards.

(a) The ration cards issued in a pakuthy should be registered with the merchant of that pakuthy only.

(b) The number of merchants in a pakuthy should be reduced so that there may not, as a general rule, be more than one retail ration merchant per square mile and one wholesale ration distribu-

tor per four square miles in the rural area.

(c) i. The Rationing Regulations prescribes 400 (four hundred) as the maximum number of cards to be registered with a retail distributor. This number may be increased to 500 (five hundred). Action is being taken to amend the Regulation accordingly. It may also be laid down as a general rule that a retail ration merchant must have at least a minimum of 200 (two hundred) cards registered with him.

ii. No ration dealer against whom any proceedings have been started shall, as a general rule, be permitted to continue the rationing business. Those who have been fined or otherwise punished will be permanently debarred from continuing as ration dealers. It is desirable, as far as possible, to have a new set of respectable ration dealers in all the taluks. In all such cases the Tahsildars will carefully prepare and submit a list to the Division Peishkars and get the list sanctioned.

(d) The rule that the cardholder can register himself with any retail distributor in the pakuthy should be given wide publicity.

(e) Cardholders are to present the counterfoils and get their new ration cards. If merchants collect these counterfoils and present them, then no card should be issued. On the otherhand, the merchants who collect such counterfoils should be disqualified from functioning as ration merchants. The counterfoils of the registered cards should be kept in the Taluk Cutcherry itself and never with the retail distributor or any others.

(f) In addition to the entries in Form IV Register, the retail distributor should be required to note the number of adults and non-

adults against each of the ration cards registered with him.

(g) All ration cards should be issued only with the signature

of the Tahsildar. No facsimile should be used.

(h) The provisions of the Rationing Regulations regarding the preparation and acceptance of the Form IV Register should be strictly followed.

Date of new Ration Cards.

The date on which the new ration cards should come into force shall be the 9th Mithunam 1121/23rd June 1946. A Notification to the above effect will be published. The old cards will cease to be valid with effect from the above date.

The ration card holders are to be asked to produce the old cards at the time of the issue of the new cards and the Rationing Authority will cancel all columns in the old card which are not required between the date of its production and the 9th Mithunam

1121.

IV. Checking of enumeration lists. The Division Peishkars will arrange for the enumeration already conducted, being carefully checked by proper agencies, will take immediate action to rectify the defects and discrepancies noticed and will hand up to Government such of the officers etc., as are. found responsible for furnishing wrong figures.

PRESS NOTE.

The food scarcity that Travancore is facing today with the rest of the world has necessitated the conservation of all available foodstuffs in the State. The imposition of certain restrictions in the use of foodstuffs, with a view to prevent their avoidable wastage and to make them available for human consumption has therefore become necessary. Government are therefore issuing an order prohibiting the use of flour in soap making industry. The attention of the public is drawn to Flour (use in Soap Making) Prohibition Order 1121 published by Government in their Notification R. O. C. No. 8642/46/Fd., dated 24th June 19:6 which accordingly prohibits the use of flour of any of the foodgrains specified therein, in the manufacture of soap.

PRESS NOTE.

With a view to ease the present acute food situation in the country, Government have imposed certain restrictions on the export of supplementary food stuffs, such as eggs, fish and bananas. In arriving at this decision, Government were in hopes that the prices of the above commodities will come down, so that they would be within the reach of the public at large. However, Government regret to note that notwithstanding the ban on the export so imposed, the prices of the above articles have not come down. Further, it is also reported that some sections of the fisher-folk have become less diligent in their avocations as a result of the ban on the exports and the apprehended decrease in price of fish. It will be noted, in this connection, that even under the restricted arrangement the exporters of eggs and fish are given a reasonable opportunity to export a fair portion of the commodities produced by them. This step has been taken in order to encourage greater production of the above commodities within the State, and to maintain the markets now held by Travancore dealers outside the State. In case the production of the above mentioned commodities is not kept up or increased, and in case the inflated prices do not come to the normal, it may become necessary to fix a maximum price in respect of these commodities, and to enforce it by prosecutions for infringement. In order to avoid such a contingency this Governe ment would appeal to those persons who are dealers in eggs, fish and bananas, to take stock of the situation and co-operate with Government to the fullest possible extent and to produce as much as they can of the above commodities and to release them to the public at reasonable cost in order to tide over the present food

CIRCULAR.

With effect from the 9th Mithunam 1121 when the new Ration cards will come into force in all the Rationing Areas of the State excepting the City of Trivandrum, the Municipal areas of Nagercoil, Quilon, Alleppey and Kottayam and the Taluks of Thovala Shencottah, Peermade and Devicolam, the following procedure will be followed by all the Tahsildars and the Municipal Rationing Officers of the State in the matter of checking the accounts of the Wholesale and Retail Dealers functioning under the Rationing Scheme and compiling the weekly accounts.

- 1. The accounts of all the Wholesale and Retail Dealers in the Rationing area should be checked every week by the Rationing Officer or by one of his subordinate officers authorised by him for the purpose whenever he is not in his headquarters.
- 2. The fact of checking should be marked in the Daily Transaction Register itself with the checking officer's initials and date.
- .3. For purpose of convenience, the Wholesale and Retail Dealers of the Rationing area may be listed into five or six groups, each of the groups to bring their books to the Rationing Office on one of the week days. After the accounts are checked the Rationing Authority, if due, will be prepared and issued on the same day itself. The week day on which the merchant is thus required to submit his accounts to the Rationing Officer should be treated as a holiday to the merchant when he should not be permitted to conduct any sales. On no account should the merchant be required to wait for the next day to get his Ration Authority or to receive back his account book.
- 4. Along with the checking of the accounts the Rationing Officer will also arrange for the details of the accounts and of the Ration Authority issued being noted in a consolidated statement of stocks and sales, the sample form for which is sent herewith. Necessary printed copies of this form are being sent separately. By Sunday every week the entries in respect of all the Wholesale and Retail Merchants of the area will thus be complete and after totalling up the columns and noting down the additional information as required therein in respect of local paddy, etc., the final statement will be sent to the undersigned so as to reach this office on every Monday.

One of the clerks in the Rationing Office should be specially assigned to attend to the preparation of this statement and he will also be held responsible for its proper preparation and prompt despatch. The name of the Clerk so assigned with the work should also be intimated to this Office.

The checking of the accounts and the preparation of the statement will commence from Monday the 17th Mithunam 1121. The first statement should reach this office by Monday the 24th Mithunam 1121 and the subsequent statements on every succeeding

This statement is in supersession of all other periodical statements in respect of Rationing that are being called for from the Area Rationing Offices.

PRESS NOTE.

With a view to eliminate from the rationing business wholesale and retail distributors who have been guilty of gross violations of the Rationing Regulations, or have otherwise been responsible for serious irregularities, Government had issued instructions to all Rationing Officers that dealers who had been punished by the levy of fines or otherwise should be debarred from continuing the ration business. It is now reported that in many cases the punishments inflicted were for mere technical offences involving no moral turpitude and that a uniform application of the rule, irrespective of the gravity of the offence, may result in considerable hardship to the merchants concerned. Government have therefore decided that the question whether a wholesale or retail distributor should be allowed to continue the business should depend not on the fact of punishment alone, but on the nature and gravity of the offence which led to the punishment and that those who are guilty of only simple technical offences need not be disqualified from continuing as ration merchants. Ration dealers prejudicially affected by the new rule are therefore allowed to submit their representations within seven days of the publication of this Press Note, to the State Food Rationing Officer, who will after examining the merits of each case and if found necessary, after reference to the Rationing Officers concerned, decide whether the offence is serious enough to justify the ration distributor being completely debarred from functioning

The State Food Rationing Officer is being directed to complete the disposal of all such representations within one month from the date of this Press Note. As Government recognise that the temporary cessation of business by these merchants pending the final porary cessation of business by these merchants pending the ration disposal of the above matter might result in their losing the ration business completely, the Rationing Officers are also being informed business completely, the Rationing Officers are also being informed that these merchants may be permitted to continue as ration distributors until the representations referred to are disposed of butors until the representations referred to are disposed of

The above provisions will apply to all the Rationing Areas in the State including the City of Trivandrum.

PRESS NOTE.

In Notification ROC. No. 1699/45/Con., dated 17-6-1946. Government have laid down that the value of a unit of ration would be 3 1/2 nazhies of rice and one nazhi of wheat, wheat products or pulses, i. e., 12 oz. of foodgrains per adult per day. In view of low stock position in the State, Government were able to allot to the various Ratiouing Areas from the fortnight commencing 9th Mithunam 1121, stock at the rate of only 3 nazhies of rice and 1 nazhi of wheat etc., per unit. The basic ration had thus to be reduced for the time being from 12 ozs. of foodgrains per adult per day to 10 ozs. This arrangement will however, be only temporary and Government will take the earliest opportunity to restore the size of the ration to the level prescribed in the Notification dated 17-6-1946, on receipt of larger stocks expected to arrive shortly.

PRESS NOTE.

The proprietors and representatives of important Hotels and Tea Shops in the City met the Director of Food Supplies on 4-7-46, and represented to him the difficulties experienced by them at present in getting adequate quantity of foodgrains to meet the normal

daily requirements in their establishments. They have also pointed out to him that after the opening of the courts and educational institutions it has been found impossible to meet even a portion of the demand.

With a view to ensure a regular and systematic supply of foodgrains to the catering establishments, the Director of Food Supplies has recommended to Government certain proposals based upon which Government have sanctioned the following arrangements.

The Tea Shops will be allowed only 25% of the units originally allotted to them; and grains other than rice will alone be supplied on units thus allotted. No rice preparation should be made available for sale in Tea Shops. Government expect to receive shortly some consignments of wheat flour which, on receipt, will be issued to Tea shops also.

In the case of the hotels, 50% of the units of ration which they were getting before the cut was effected will be allowed on the understanding that no portion of the said allotment will be utilised for any preparation other than meal. It is noted that the Proprietors and representatives who met the Director of Food Supplies have given him an assurance that no meal with more than three courses would be served by them and that not more than (8) eight ennas would be charged by them for a meal.

Regarding the difficulty in the messing arrangements for the students referred to by the deputation, Government are issuing instructions to the City Rationing Officer, Trivandrum, to arrange for individual temporary ration cards being issued to the students against their applications and on their producing a certificate as to the bonafides of the applications, from the head of the institution in which the applicants are studying. They will not, however, be entitled to ration in their family ration cards in the meanwhile. The students who are given temporary cards are at liberty to purchase the rations or to hand over the cards to the Proprietors of the Hotel from where they are taking meals.

Please refer to G. O. D. Dis. No. 54/46/Fd., dated 17th July 1946 regarding the working of Co-operative Societies in the matter of rationing. Government consider that the strict enforcement of the

rule that no retail distributor shall register more than 500 cardmay prejudice the working of some Co-operative Societies which are reported to be functioning satisfactorily. Refusal by a Society, with a large number of members to register cards exceeding 500 may result in some of the members being denied the privilege of registering the card in their own Society. With a view to avoid such contingencies and to enable the Societies to function to the maximum convenience of its members, Government consider that a relaxation of the above rule is necessary.

The Director of Food Supplies has therefore been authorised to permit such of the Co-operative Societies, as are recommended by you, to open branches provided the main depot as well as the branches are subject to the same bye-laws and provided they satisfy the rules in force regarding the maximum and minimum number of cards and the area in respect of which the cards may be registered.

PRESS NOTE.

It is reported that persons who apply for Ration Card on arrival in a Rationing area, do not produce along with their applications, any proof of having surrendered their previous ration cards. The failure in this respect inconveniences the applicants themselves in getting the new cards and also affords scope for double ration being drawn. The public are therefore informed that applicants for issue of Ration Card from persons who have newly moved into a Rationing area should be invariably accompanied by a certificate from the Rationing Officer of the area in which the applicant was previously residing, to the effect that either the previous Ration Card has been surrendered or that a corresponding reduction has been made in the units in the previous card on account of the change of residence of the applicant from the Rationing area. Failure to comply with these instructions will result in delay in issuing the Ration Card since the Rationing Officer will be unable to issue the card until he obtains the above information.

CIRCULAR.

On scrutinising the weekly statements of stocks and sales so far received from Taluk and other Rationing Officers many defects are noticed in the preparation of the statements. These have been opointed out to the respective officers from time to time. These defects which are more or less of a general nature are found to be repeated in some cases. The following instructions are therefore issued for the guidance of all Rationing Officers, their assistants and clerks:—

- 1. Both the wholesale and retail distribution statements must be forwarded on the same date.
 - 2. Statements for each week should be prepared separately.
- 3. The period to be noted in the heading of the statements is the week during which the statements are reported and not the week to which the transactions by the dealers relate. Thus the figures under opening balance, receipts, sales and closing balance will relate to the period previous to that noted in the heading and the figures under Ration Authority to the period noted therein.
- 4. The printed headings of the columns should not be tampered with. Wheat should be noted in the extra column provided. When any grain is issued in addition to rice and wheat the same should be entered in the column provided for paddy the heading being suitably altered.
- 6. The quantities of various foodgrains in the Retail Distribution statement (excepting columns 26 to 28) should always be expressed in terms of edangalies. (Some Taluk Retioning Officers are giving this information in bags.)
 - 6. The sheets of a statement should be serially numbered.
- 7. Some Rationing Officers are using sheets from the 1st book alone instead of continuation sheets for subsequent pages. This should be avoided.

8. Particulars regarding some of rationing area, areas in square miles, number of pakuthies or wards etc., should not be omitted in any statement.

9. Page totals should be carried over progressively before ar-

riving at the grand totals for a week.

10. The columns under opening balance in a particular statement should be filled in only from the entries in the closing balance column of the previous statement.

The totals of columns "Opening balance" and "Receipts" should invariably agree with the totals of columns "Sales" and "Closing balance". Difference if any, due to issue of Special supplies not included under sales should be explained.

The balance quantities of foodgrains not taken delivery of by each wholesale distributor under Ration Authorities previously issued should be noted in the remarks column against his name in each statement.

The retail distributors should try to take delivery of the entire stocks as per ration authorities before the close of the weak

following that in which the authorities are issued.

14. Quantity of foodgrains sold should agree with the number of units utilised. The proportion of the different grains should never be altered. Differences due to variation in the composition of ration issued to hotels, restaurants, etc. must be explained.

15. Merchants should be listed into 5 or 6 groups as instructed in para 3 of G. O. R. O. C. No. 1303/46/Fd., dated 25-6-1946.

Balance quantity remaining with the Tahsildar should be the quantity available for further issue after deducting the Ration authorities issued to the wholesale merchants during the week in which the statement is prepared.

17. Fraction of a bag should not be included in ration authorities (vide Rationing Regulation 35.)

NOTIFICATION.

In exercise of the powers conferred by sub-rule (2) of Rule 81 of the Defence of Travancore Rules, the Government of His Highness the Maharaja are pleased to make the following Order and to direct with reference to sub-rule (1) of Rule 119 of the said Rules that notice of the Order shall be given by the publication of the same in the Government Gazette and by the issue of a Press Note indicating the nature of its provisions.

- 1. (1) This Order may be called the Paddy (Acquisition and Movement) Control Order, 1122.
 - (2) It extends to the whole of Travancore.
 - (3) It shall come into force at once.

In this Order, unless there is anything repugnant in the subject or context,-

(a) "authorised officer" means an officer authorised by the

Division Peishkar to acquire paddy under this Order:

(b) "The Assistant Purchase and Rationing Officer" means the officer appointed by the Government to assist the Tahsildar in the supervision over the acquisition, stocking and distribution of paddy under this Order;

(e) "paddy" includes rice, whether raw or boiled, and also

- (d) "stockholder', means a person who on his own account sheaves; or on account of any other person holds any stock of paddy.
- 3. (1) Every person who owns or is in possession of any land from which he receives paddy by his own cultivation or otherwise shall be liable to sell to the Government paddy in quantities equal to the settlement pattom due on each such land:

Provided that it shall be open to the Tahsildar to reduce the quantity to be sold by any person in cases in which the entire quantity could not be sold on account of failure of crops, drought, flood or damage by insects and also to order that the quantity due to be sold by any person may be purchased in instalments:

Provided further that the Tahsildar may by written order direct the sale of a reasonable proportion of the yield from any land on which paddy is cultivated and the settlement pattom of which is fixed in cash.

(2) Notwithstanding anything contained in sub-clause (1) every stockholder shall also be liable to sell to Government such quantity of paddy which is in excess of the quantity reasonably required by him for the stocking of seed, cultivation expenses and for bonafide domestic consumption as the Tahsildar may by written order specify in each case. .

- 4. No person who owns or is in possession of any land from which he receives paddy by his own cultivation or otherwise and no stockholder shall sell or otherwise dispose of any paddy except to the Government.
- 5. An authorised officer shall be competent to purchase on behalf of the Government paddy from such stockholders in such area and in such quantities as the Tahsildar may from time to time by written order direct.

6. An authorised officer purchasing any stock of paddy under this Order shall pay to the stockholder the price thereof at such

rate as the Government may fix from time to time.

- 7. The Tahsildar shall have power to delegate to the Assistant Purchase and Rationing Officer all or any of his powers and functions under this Order with the permission of the Division Peishkar.
- 8. Where the Tahsildar is satisfied that any stockholder has refused to sell to the Government the quantity of paddy fixed by him, it shall be lawful for him to acquire the quantity so fixed from the stock held by the defaulter or his agent and for the purpose of acquisition he shall have power to enter upon any premises wherein such stock is believed to be kept and inspect such premises and any property or thing thereon and take such other steps including the sealing of barns or other receptacles wherein paddy is stored as may be deemed necessary for the acquisition and custody of any stock of paddy found thereon.
- 9. Every Division Peishkar and Tahsildar shall be competent to acquire paddy in cases of emergency.
- 10. Where any stock of paddy is acquired under clause 8 or clause 9 from any stockholder, the officer acquiring such stock shall pay or cause to be paid to the stockholder the price thereof at the rate fixed under clause 6.
- 11. With a view to securing compliance with the provisions of this Order, the Tahsildar, the Assistant Purchase and Rationing Officer or a Police Officer duly authorised by the Tahsildar shall have power—

(a) to require any person to give such information in his possession with respect to any business carried on by

(b) to inspect or cause to be inspected any books or documents belonging to or under the control of any

The food situation in the State continues to be critical, yet on account of the national importance of the Onam festival, Government have as a special case decided that during the Onam week ration should be issued at the normal level of 8 nazhies of food grains per adult per week. In addition to the existing scale of ration of 31 nazhies of rice and 1/2 mazhi of wheat per adult per week, during the Onam week (23rd to 29th Chingom) an additional quantity of one nazhi of food grains, consisting of half a nazhi each of rice and wheat would be issued per adult and half this quantity to non-adults. Sub:-Supply of foodstuffs to Indian troops and Servicemen while on leave.

The Central Government in the Food Department state that it has sometimes happened that Indian troops and servicemen, while on leave, have experienced difficulties in obtaining ration cards for commodities such as cereals, sugar, kerosene oil etc., from the local civil rationing authorities. There have also been cases in which the period of leave granted to servicemen has expired before they could be issued with ration cards.

2. In order, therefore, to ensure that the servicemen on leave ar provided with ration cards as expeditiously as possible, the following

procedure has been suggested by the Central Government.

"Officers Commanding, Units, should forward in advance application forms in the pro forma specimen enclosed, duly completed by servicemen proceeding on leave to the District Magistrate concerned, who in turn will forward it to the appropriate Civil Rationing authority. The Civil Rationing authority on receipt of the application form will fill in the counterfoil and return it to the Officer Commanding, Unit forwarding the original application form and keep • the ration card ready for delivery to the serviceman immediately on his arrival on production of the counterfoil or in case of its nonreceipt in time, a simple certificate of identification from the Officer Commanding concerned. The enquiries etc., as required in the pro forms should be completed after the ration card has been issued.

3. I request that to help the army personnel as far as possible the suggestion made above may kindly be adopted by the Travancore Government so that the health and efficiency of the Army men while on leave may not suffer.

CIRCULAR.

The Commissioner of Civil Supplies has brought to the notice of Government, that, in spite of repeated instructions, the consolidated weekly statements of stocks and sales are still not being prepared with accuracy and care in many of the rationing offices, that mistakes and omissions once pointed out are being repeated continuously and that statements sent back for correction are not promptly returned. The following irregularities are also reported:—

- 1. Information on important points such as "ration card population", "total number of cards issued" etc. is not furnished by many officers on the ground that registers contemplated in the Rationing Regulations are either not completed or have not been finally checked.
- 2. Ration cards of paddy owners are registered with retail distributors with the result that the standard requirements for each area is maintained at an inflated level.
- 3. Orders of Government fixing the maximum and minimum number of ration cards to be registered with a retail distributor as 500 and 100 respectively, are not being strictly enforced.
- 4. The sales effected by a few merchants are sometimes not included in the statements and on enquiry it is found subsequently that the particular merchants did not present their registers for scrutiny so much so that off take figures do not represent the total sales to card holders.
- 5. In many areas the number of wholesale and retail distributors is disproportionately large as a result of which no sufficient check could be exercised over them.

Government consider that at this critical juncture of acute food shortage, stringent measures should be taken in every direction for the proper conservation and distribution of all available supplies and they direct that the following instructions should be strictly followed by all Food Rationing Officers. Any failure on the part of officers will be taken serious notice of by Government.

(a) The utmost care should be taken to avoid repetition of omissions and mistakes once pointed out. The statements sent back to the Rationing Officers should be returned to the Commissioner of Civil Supplies within three days duly corrected and furnishing

additional information that may be called for.

(b) The success of the rationing scheme depends entirely on the proper and up-to-date maintenance of all registers contemplated in the Regulations and strict enforcement of the rules. The Rationing Officers should see that the registers in their offices are brought up-to-date within a week so that all relevant information could be

furnished in the weekly statements prepared thereafter.

(c) The registration of ration cards of paddy owners with merchants tends to lower the percentage of actual offtake. Cards of persons having paddy, sufficient for their consumption throughout the season, and who do not depend on ration, should never be registered with any merchant. The cards of those who partially depend on ration, should come under registration only after their stocks of paddy are completely exhausted and they begin to draw ration. Such cards as are now included in registration should be deleted immediately from "D" form register kept by the merchants and proportionate reduction effected in the number of registered units.

(d) The maximum number of ration cards that a retail distributor could register should never exceed 500. Similarly no person with less than 100 ration cards should be allowed to function as a retail distributor. Applications for exemptions from this rule should not ordinarily be entertained. But in very exceptional cases where the minimum number of cards could not be registered as in the case of hilly tracts with scattered habitations, exemptions may be granted to individual merchants by the Commissioner of Civil Supplies and Ex-Officio State Food Rationing Officer.

(e) If any merchant does not bring his accounts to the office for scrutiny, the Rationing Officer should take drastic action against him instead of sending an incomplete statement to the Commissioner of Civil Supplies. There has been gross omission on the part of officers. Warnings to merchants will not have any deterrent effect in such matters. Failure on their part to present accounts on the appointed dates should in future be visited with

immediate cancellation of licenses.

(f) All Rationing Officers should take immediate steps to limit the number of wholesale and retail distributors to the lowest minimum possible to ensure proper scrutiny and verification of their accounts and stocks without at the same time causing any

•hardship to card holders

(g) The work of scrutinising the accounts of merchants and issuing Ration authorities is being done by the Rationing clerks. On the efficiency of the work turned out by these clerks, depend the correctness and prompt despatch of the weekly consolidated statements. Both the Rationing and the Statistics clerks will be held equally responsible for the proper and timely preparation and submission of these statements. The Assistant Purchase and Rationing Officers should also devote their personal attention in this matter

(h) Specific instances of violation of the above instructions by the Area Rationing Officers will be brought to the notice of

Government by the Commissioner of Civil Supplies.

2. No owner, tenant or other holders of such lands shall conduct any operations thereon except under and in accordance with the terms and conditions of a permit issued in that behalf by the Special

Officer for Punja Cultivation.

2. If any person, who but for this Order would have been entitled to cultivate the lands is unwilling or unable to cultivate the lands under the terms and conditions that may be imposed under clause 2, the Special Officer shall lease out such lands by public auction or private negotiations.

4. Whoever obstructs such lessee or otherwise interferes with the proper and efficient cultivation of such lands shall be deemed to be

quilty of a contravention of this Order.

As the food situation is showing signs of improvement, Government have decided to revise the existing scale and composition of ration to two and a half nazhies of rice or five nazhies of paddy, three-fourths nazhy of wheat or wheat products and three-fourths nazhy of maize or pulses or gram per unit with effect from Sunday the 23rd Vrischigom, 1122. With a view to obviating the difficulties in the exercise of effective control over the rationing work in the State, Government sanction the following revised arrangements:—

At staff consisting of the Inspecting Assistant, the statistics clerks, the rationing clerk and the two peons attached to the Rationing

section of each of the Taluk offices and forming part of the Food Department will be placed under the control of the Commissioner of Civil Supplies. The Municipal Food Rationing Officers and their staff will also be under the direct disciplinary control of the Commissioner of Civil Supplies;

- 3. The Tahsildars to continue to be the local officers responsible for procurement and rationing, the existing additional staff (excluding the Assistant Purchase and Rationing Officers) recently sanctioned for the purpose of procurement being continued to be utilised for the purpose;
- 4. The Division Peishkars to continue to be directly responsible for the procurement of local paddy. The Commissioner of Civil Supplies may fix the target figures in respect of procurement for the various Taluks and the Tahsildars may furnish him as is now being done, with weekly statements etc., about the progress of purchase. The Commissioner of Civil Supplies will report to Government the weekly progress of purchase for the whole State. He will scrutinise the statements and send up reports to Government whenever action has to be taken to speed up procurement. He will also continue to obtain paddy accounts from the Tahsildars and forward them to the Accountant General after check and countersignature;
- 5. The Commissioner of Civil Supplies and the Deputy Commissioner of Civil Supplies acting under instructions from the Commissioner of Civil Supplies to be in charge of inspection of rationing throughout the State with a view to intensify that work:
- 6. Mr. N. Raghavan Pillai, acting Superintendent, Secretariat, to be appointed as Assistant Commissioner of Civil Supplies in the office of the Commissioner of Civil Supplies on his present pay plus an allowance of Rs 75 per mensem in the place of Mr. P. Balakrishna Pillai, Deputy Commissioner of Civil Supplies who will hereafter attend to inspection work alone;
- 7. Messrs. K. Parameswaran Nair, and P. Gopalan Nair, Assistant to the Commissioner of Civil Supplies and Mr. George Thomas, Assistant Commissioner of Civil Supplies to be in charge of inspection of rationing work in the three Revenue Divisions and posted to Trivandrum, Quilon and Kottayam respectively. Mr. George Thomas will also continue to be in charge of his present work of supervision over the transport of food grains, commandeering of vehicles etc., and will retain his present staff. The above three officers will also conduct inspection of the Government Foodgrains Godowns in their respective Divisions;
- 8. The Assistants to the Commissioner of Civil Supplies (inspection) at Trivandrum and Quilon, each to be given the following staff:
 - 1 clerk on Rs. 45-5:75.
 - I clerk on Rs. 30-3-45.
 - 1 Typist on Rs. 30-3-45 and
 - 8 peons on Rs. 14-1/3-17 and

9. Mr. N. Nagendra Bhattar, Assistant Superintendent, Secretariat to be appointed as Assistant to the Commissioner of Civil Supplies on a salary of Rs. 175 per mensem vice Mr. P. Gopalan Nair.

The additional expenditure on account of the above proposals will be met from the lump sum provision to the Food Department already provided in the Budget for 1122 M. E.

As regards requisitions received for the release of grams and other food stuffs out of Government stocks, from contractors engaged for the supply of such grams etc., to Government Institutions, Government agree with you in thinking that as the private sale of black gram and the like cereals are not prohibited by Government, the contractors who have entered into agreements only with the motive of personal benefit may be asked to procure the stuff from the open market and supply at the specified rates agreed to, if necessary.

In regard to the supply of such articles to Government Institutions it is however advisable to make the supply direct by the Rationing Department itself, thereby avoiding the middleman and his undue profit. Whenever such supplies are deemed necessary the head of the institution may apply direct to you and you in you turn will direct the concerned depot officer to release the required quantity to the Head of the Institution on production of the chalar receipts in token of having remitted the value thereof.

For this, the services of the Vanchi Poor Fund and its branches, Kara Committees, Village Unions, Panchayats, Co-operative Societies and other bodies will be availed of and the foodgrains to be surrendered can be entrusted to such bodies. The quantities sogsurrendered will be released by the Area Rationing Officers for distribution in the locality from which they have been collected. The Area Rationing Officers will notify the names of the local bodies in the different areas to whom foodgrains may thus be handed over. Every precaution will be taken to see that the quantities of foodgrains surrendered by the generous public are not misused but are properly utilised for the purpose for which they are intended.

PRESS NOTE.

The recent enhancement of the size of the rice ration seems to have created an impression among the public that the food situation in the State has considerably improved. Government wish to make it clear that the situation has not eased substantially and that the over-all food position is still below the safety line. Government would therefore like to impress upon the public the need for exercising the strictest economy in the use of food stuffs with a view to conserving all available food resources in the State to the maximum possible extent to tide the difficult period ahead.

The use of cereals for luxury food and of milk and milk products in the preparation of ice-cream, sweet-meats etc., intended for sale at public places, will, as far as possible, be discouraged. Quotas of cereals issued to non-residential establishments like bakeries, teashops, restaurants etc., will be restricted to the irreducible minimum and the issue of rice to European style establishments prohibited. The Area Rationing Officers have been instructed to see that the above restrictions are enforced in their respective areas. These measures will be withdrawn when the food position improves.
